Global commentary

- **US** markets closed higher Wednesday, with the Nasdaq hitting a record despite brief volatility on reports Trump might fire Fed Chair Powell. Dow rose 0.5%, Nasdaq and S&P 500 gained 0.3%. Core PPI (MoM) for June came below forecast (0% vs 0.2%) (Source: Reuters).
- **European** markets fell as chip stocks dropped after ASML warned of slower growth. Trump-Powell headlines also weighed on sentiment. CAC 40, DAX, and FTSE 100 declined 0.6%, 0.2%, and 0.1%, respectively. UK's Core CPI (3.6% vs 3.4%) and RPI (4.4% vs 4.3%) exceeded estimates (Source: Reuters, FXStreet).
- Asia-Pacific markets traded mostly higher as investors assessed Japan's second straight export drop and Trump's denial of firing Powell (Source: CNBC).
- Oil prices rose early Thursday, rebounding on strong economic data and signs of easing trade tensions (Source: CNBC).
- Gold edged lower as a firmer dollar and Trump's reassurance on Powell reduced market anxiety (Source: CNBC).

Saudi commentary

- Tadawul All Share Index (TASI) fell 0.51% to 11,038.74. Twenty of the twenty-one sector indices closed lower, led by Media & Entertainment (-1.8%) and Food & Beverages (-1.4%). Consumer Staples Distribution & Retail (+0.4%) was the only gainer. The advance-decline ratio stood at 51/195, with trading turnover at approximately SAR 4.0bn.
- **MESC** announced that its subsidiary in Ras Al Khaimah secured AED 120mn (SAR 122.6mn) in Shariah-compliant financing from First Abu Dhabi Bank (FAB) in the UAE (Source: Tadawul).
- Ministry of Industry and Mineral Resources issued 37 new mining licenses in May 2025, raising the total active licenses in the sector to 2,468 (Source: Argaam).




