Global commentary

- **US** markets closed lower on Monday, with the S&P 500 snapping its longest winning streak in 20 years as investors weighed Trump's latest tariff announcement ahead of this week's Fed meeting. Nasdaq, S&P 500, and Dow fell 0.7%, 0.6%, and 0.2% respectively. ISM Services PMI (Apr) beat expectations at 51.6 vs 50.6 (Source: Reuters, FXStreet).
- **European** markets ended mixed as investors focused on trade tensions and the upcoming Fed decision. DAX gained 1.1%, CAC 40 slipped 0.5%, and FTSE 100 was closed for a bank holiday (Source: Reuters).
- **Asia-Pacific** markets traded mostly higher this morning as regional trade talks and stronger Asian currencies, supported by a weakening dollar, drew attention (Source: CNBC).
- **Oil** steadied on Tuesday after falling to four-year lows in the prior session following OPEC+'s move to ramp up output, heightening oversupply fears amid weaker demand outlook from tariffs (Source: CNBC).
- **Gold** hit a two-week high as tariff concerns boosted safe-haven demand ahead of the Fed's policy meeting (Source: CNBC).

Saudi commentary

- **Tadawul All Share Index (TASI)** rose 0.10% to close at 11,422.95. Seventeen of the twenty-one sector indices ended higher, led by Materials (+1.8%) and Pharma, Biotech & Life Science (+1.2%), while Media & Entertainment (-0.8%) and Utilities (-0.6%) led the decliners. The advance-decline ratio stood at 153/84, with trading turnover at approximately SAR 5.2bn.
- **Al Arabia** signs 10-year deal via affiliate to operate BRT route billboards in Greater Cairo (Source: Tadawul).
- **Al Ashghal Al Moysra** secures SAR 2.16mn warehouse management contract with government entity (Source: Tadawul).
- **Al Rajhi Takaful** board recommends buyback of up to 300,000 shares for ESIP (Source: Tadawul).
- **Ataa Educational** signs MoU with Japan's Ikueikan Group to explore school projects in Saudi Arabia (Source: Tadawul).
- **Arabian Drilling** extends long-term contracts for two onshore rigs with Saudi Aramco (Source: Tadawul).
- **Flynas** announces its intention to float on the Saudi exchange (Source: Argaam).

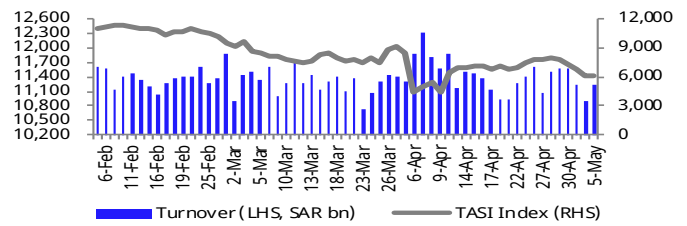

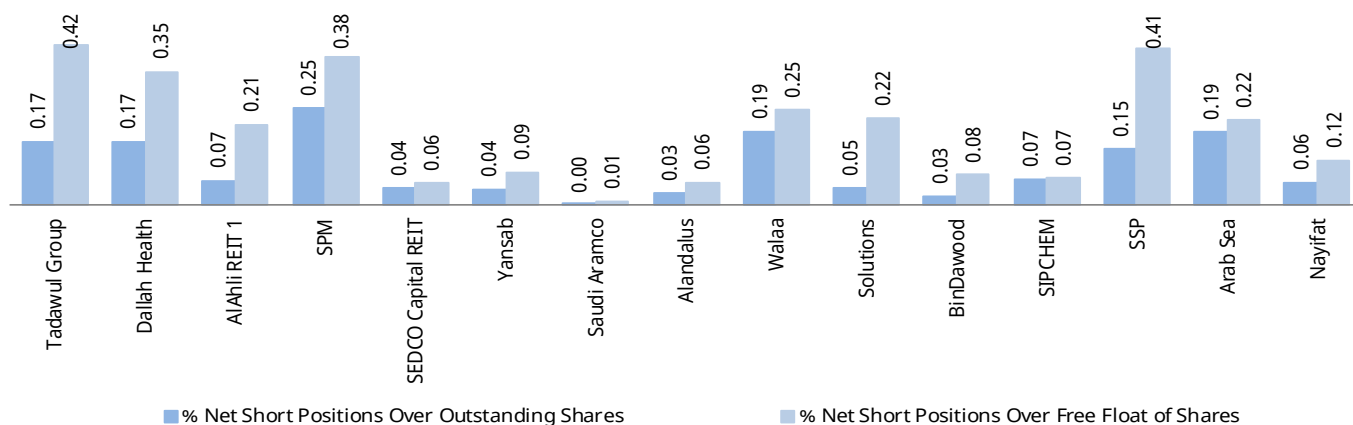
